Business Justification

Intellivue has been used as an enterprise document management solution for many years and has become a business-critical tool for 12 partner agencies. It stores and indexes documents, provides workflow capabilities, and more. With a growing database of millions of document pages, the platform is a cornerstone of digital government operations for Franklin County. This project will provide new functionality and increased security in a cloud-based format.

Description

In 2024 the Data Center transitioned on-prem Intellivue to cloud-based IntelliCloud. This project will migrate current applications and data into the IntelliCloud content management system and retire unused applications and data for historical retention.

This is a fixed-price engagement. The contract was developed by Purchasing and approved by the Prosecuting Attorney's office.
